We participate in the design and development stages of new vehicle parts, procure raw materials from the Honda Motor Co., Ltd. group, manufacture parts, and deliver them to the group.

Although we have close capital and business relationships with the Honda Motor Co., Ltd., we maintain a certain degree of independence in our business operations.

(Note) 1. Transaction terms and conditions or policy for determining transaction terms and conditions, etc.

- (1) Sales prices are determined based on economic rationality, taking into consideration market prices and our production technology, etc., and estimates are prepared and submitted to our customers for price negotiations.
- (2) The purchase price of raw materials is determined through price negotiations based on market prices.
- (3) The method for determining compensation for molds and other items due to the discontinuation of production related to the sale of products (molds, etc.) is as follows: We submit a compensation application form prepared by taking into account the unrecovered portion of mold manufacturing costs and other expenses incurred due to the discontinuation of production by our customers, and then negotiate to determine the compensation amount.
