#### Announcement concerning Change of Independent Auditor

The company announced that it resolved at a meeting of the Audit & Supervisory Board held on May 21, 2025, to change its independent auditor, who performs the audit certification set forth in Article 193-2, paragraphs (1) and (2) of the Financial Instruments and Exchange Act. The details are described below.

3. Reason for selecting the party stated in 2. (1) as a candidate for independent auditor  
As a result of the business integration of Russell Bedford HIBISCUS Tokyo Office and UHY Tokyo & Co. to be implemented on July 1, 2025 (hereinafter referred to as the "Business Integration"), the audit work of the current Hibiscus Tokyo Office will be transferred to UHY Tokyo & Co.. This will enable us to maintain continuity in audits, and we expect that audits will be conducted appropriately and appropriately from the perspectives of a global audit system, independence, expertise, quality control system, etc., and therefore we have determined that UHY Tokyo & Co. is the suitable candidate.

6. Reason and background for determining or leading to change  
Russell Bedford HIBISCUS, the Company's accounting auditor, will retire due to the expiration of its term of office at the conclusion of the 77th Ordinary General Meeting of Shareholders, scheduled to be held on June 25, 2025. As the certified public accountant at Russell Bedford HIBISCUS who was in charge of the Company's audit work will be transferred to UHY Tokyo & Co. following the Business Integration, UHY Tokyo & Co. will be newly appointed as the accounting auditor candidate for the reasons stated in 3 above.
