## Notice Regarding the Establishment of an Overseas Subsidiary (Third-Tier Subsidiary) by Our Subsidiary and Second-Tier Subsidiary

We are pleased to announce that, at the Board of Directors meeting held June 11, 2025, Chikaranomoto Holdings Co., Ltd. resolved to decide to establish a new subsidiary (third-tier subsidiary) in the Republic of Indonesia by CHIKARANOMOTO GLOBAL HOLDINGS PTE. LTD. (CGHD), our consolidated subsidiary, and PT. IPPUDO CATERING INDONESIA (ICI), our second-tier subsidiary.

### 1. Reason

Our group operates both domestically and internationally with the mission of sharing Japanese food culture, particularly ramen, with the world, based on our corporate philosophy "Keep Changing to Remain Unchanged." As of the end of the fiscal year March 2025, we have expanded to 296 stores across 15 countries and regions. Through extensive overseas expansion, we have cultivated our philosophy, human resources, products, store design, and services, integrating them at a high level to form our core competence in branding. Our group has set a management plan aiming for sales of 50 billion yen and operating profit of 5 billion yen or more by the fiscal year ending March 2028. To achieve this goal, we are establishing a local subsidiary in Indonesia to expand our business by introducing a halal business model.
