# Notice Regarding Financing for Aircraft Acquisition

Skymark Airlines Inc. (hereinafter "Skymark") would like to announce that a resolution regarding the financing for an aircraft acquisition was passed at the meeting of the Board of Directors held on June 20, 2025 as follows.

### 1. Reason for the Financing

Skymark has decided to acquire Boeing 737-10 aircraft, and this financing is intended to cover a portion of the acquisition funds (such as advance payments) for some of these aircraft.

This is based on the premise of a future sale-and-leaseback of the aircraft to Atlantis Aviation Corporation. Under this structure, the Company will receive advances on the sale proceeds from Atlantis Aviation Corporation in stages before the aircraft are delivered. These funds will then be utilized for the prepayments to Boeing.
