1. The reason for investment (change in subsidiary)

Our consolidated subsidiary, Woven by Toyota, Inc. ("Woven by Toyota") (formerly Woven Planet Holdings, Inc.), established Woven Capital, L.P. ("Woven Capital"), a global investment fund, in December 2020. In connection with the expansion of our investment business, we decided to make an additional investment in Woven Capital on July 10, 2024, and we completed the investment on July 26 of the same year. As a result, the total amount of our investments exceeded 10% of our capital, thereby making Woven Capital one of our specified subsidiaries.
