1. Qualitative Information on Semi-annual Consolidated Financial Results

(1) Explanation of operating results

The forward-looking statements in this document are based on the judgement that the Company made as of June 30, 2025.

With a mission, “We create more ‘fun’ to work,” the Group operates the ICT business focused on the development and sales of SPIDERPLUS, which is a SaaS (Note) application for construction management that helps solve challenges in the construction industry by digitally transforming operations at construction sites.

Note: SaaS (Software as a Service) refers to a form of service allowing users to connect to and use software over the internet rather than install the software in users’ computers.

The construction industry, where the Group operates, is expected to continue to experience steady demand mainly for redevelopment of urban areas and maintenance and upgrading of aging infrastructure. Meanwhile, productivity improvement has become an important management challenge for the whole industry, due to labor shortages caused by the declining birthrate and aging population, soaring labor and construction material costs, and the need to comply with regulations on maximum overtime hours in accordance with the Act on the Arrangement of Related Acts to Promote Work Style Reform, which took effect in April 2024.

To address these issues, the Group has developed and provided SPIDERPLUS as a service that contributes to labor savings and improvement in operational efficiency through digitization and digitalization of construction management tasks. SPIDERPLUS is used mainly by site supervisors of general contractors and subcontractors and is typically introduced at large-scale construction sites.

Players in the construction industry are accelerating their efforts to utilize IT against the backdrop of the heightened needs for addressing labor shortage and compliance with law and regulations. Given this market environment, the Group is focusing on strengthening its product and organizational structure, expanding its sales force, and reinforcing cooperation with partner companies to accurately capture the growing investment demand for construction digital transformation (DX) and gain a higher market share in the industry.

Under the above business environments and management decisions, SPIDERPLUS, a service that promotes DX in the construction industry and contributes to productivity improvement and cost reduction, experienced steady growth in the number of contracted companies and revenue per contracted company by effectively capturing IT investment demand in the industry.

As a result of the above, the Group continued to record strong growth of SPIDERPLUS during the six months ended June 30, 2025 (the “period under review”) in the numbers of contracted companies and the monthly revenue per contracted company, or ARPA, as of June 30, 2025 at 2,172 companies (+9.4% YoY) and 185 thousand yen (+11.3% YoY), respectively. For the period under review, the Group reported net sales of 2,360,312 thousand yen (+23.5% YoY), operating loss of 29,010 thousand yen (compared to 347,492 thousand yen operating loss for the same period a year ago), ordinary loss of 33,457 thousand yen (compared to 347,840 thousand yen ordinary loss for the same period a year ago), and net loss attributable to owners of the parent of 38,901 thousand yen (compared to 353,276 thousand yen net loss attributable to owners of the parent for the same period a year ago).

(2) Explanation of financial position

Assets

Total current assets as of June 30, 2025 amounted to 3,359,206 thousand yen, down 36,405 thousand yen from December 31, 2024. This is mainly due to a decrease in cash and deposits of 96,672 thousand yen, which is partially offset by increases in accounts receivable – trade of 31,099 thousand yen and other assets of 27,638 thousand yen.

Total non-current assets amounted to 749,715 thousand yen, down 66,132 thousand yen from December 31, 2024. This is mainly due to a decrease in software of 59,488 thousand yen due to amortization of software.

As a result, total assets amounted to 4,108,922 thousand yen, down 102,538 thousand yen from December 31, 2024.

Liabilities

Total current liabilities as of June 30, 2025 amounted to 1,220,369 thousand yen, up 2,821 thousand yen from December 31, 2024. This is mainly due to increases in accrued expenses of 22,657 thousand yen and other current liabilities of 38,349 thousand yen, which is partially offset by a decrease in accounts payable – other of 55,313 thousand yen.

Total non-current liabilities amounted to 268,804 thousand yen, down 79,338 thousand yen from December 31, 2024. This is mainly due to a decrease in long-term borrowings of 78,870 thousand yen.

As a result, total liabilities amounted to 1,489,174 thousand yen, down 76,517 thousand yen from December 31, 2024.

Net assets

Total net assets as of June 30, 2025 amounted to 2,619,748 thousand yen, down 26,021 thousand yen from December 31, 2024. This is mainly due to a decrease in retained earnings of 38,901 thousand yen resulting from the recording of net loss.

(3) Explanation of cash flows

As of the end of the period under review, cash and cash equivalents (hereinafter “net cash”) amounted to 2,644,100 thousand yen, down 96,672 thousand yen from December 31, 2024. The overview of each cash flow and its factors during the period under review are as follows:

Cash flows from operating activities

Net cash used in operating activities during the period under review amounted to 13,030 thousand yen (compared to net cash used of 322,972 thousand yen for the same period a year ago). This is attributable mainly to a decrease in net cash due to net loss before income taxes of 33,455 thousand yen and decrease in accounts payable – other of 55,453 thousand yen, which is partially offset by an increase in net cash due to depreciation of 77,916 thousand yen.

Cash flows from investing activities

Net cash used in investing activities during the period under review amounted to 16,610 thousand yen (compared to net cash used of 45,299 thousand yen for the same period a year ago). This is attributable mainly to purchase of intangible assets of 16,899 thousand yen.

Cash flows from financing activities

Net cash used in financing activities during the period under review amounted to 67,030 thousand yen (compared to net cash provided of 383,333 thousand yen for the same period a year ago). This is attributable mainly to a decrease in net cash due to repayments of long-term borrowings of 78,870 thousand yen, which is partially offset by an increase in net cash due to proceeds from issuance of shares resulting from exercise of share acquisition rights of 12,882 thousand yen.

(4) Forward-looking information including consolidated earnings forecast

No change has been made to the most recently announced forecast of full-year financial results for the fiscal year ending December 31, 2025.
