Notice Regarding Change in Reportable Segments

ExaWizards Inc. (hereinafter, “the Company”) hereby announces that the Board of Directors resolved at its meeting held on August 12, 2025, to change the reportable segments effective from the first quarter of the fiscal year ending March 31, 2026, as follows.

1. Purpose to Change Reportable Segments

Since its founding, the Company has developed a business model called the “Improving model revolving around AI (AI Guru-Guru Model).” This model aims to solve social issues by identifying industry-wide challenges through collaboration with individual customers (AI Platform Business) and developing these into versatile products and services (AI Products Business). In recent years, particularly with advances in generative AI technology, the development of products based on insights gained from providing individual solutions has accelerated, and the “AI Guru-Guru Model” has begun operating as a full-fledged cycle. Additionally, STADIUM Co. Ltd., joined the group as a subsidiary in 2023 and has grown into a business (Other Service Business) that has contributed significantly to our performance since last fiscal year.

To more appropriately reflect these changes and growth in business activities, as well as the accompanying changes in our management structure, the Company will change its reportable segments effectively from the first quarter of the fiscal year ending March 31, 2026. Specifically, given the remarkable growth of the AI Products Business, product-related operations previously included in the AI Platform Business and Other Service Business will be separated and integrated into the AI Products Business to further accelerate product growth. Furthermore, the conventional AI Platform Business, which explores challenges while deeply engaging with customers and sources product ideas, will be integrated with the Other Service Business to form the AI Solution Services Business, enabling us to discover a broader range of customer challenges.

2. Overview of New Reportable Segments

Due to the reasons stated above, the Company will reorganize into two segments as shown in the following diagram.
