### Notice Regarding Details of the Shareholder Benefit Program

#### 2. Details of the shareholder benefit program


Eligible shareholders may select one gift from the Company's original catalog or choose to make a donation, based on the number of shares held and the number of years held continuously.

\*If 1,000 shares or more but less than 3 years (JPY3,000 worth) and 300 shares to less than 1,000 shares for 3 years or more (JPY4,000 worth) both apply, it will be treated as 300 shares to less than 1,000 shares for 3 years or more (JPY4,000 worth).

## (2) Donations

### Japanese Red Cross Society

## 3. Determination of continuous holding period

Shareholders who have been continuously recorded under the same shareholder number in the Company's shareholder register at the end of each quarter from September 2022 through September 2025, holding at least the required number of shares, will be deemed to have a continuous holding period of three years or more.
