## Notice Concerning Revision to Financial Results Forecast for 2Q (Interim Period) of Fiscal Year Ending March 2026

Based on recent business performance and other factors, WOWOW INC. has revised its financial results forecast (consolidated/non-consolidated) for 2Q (Interim Period) of Fiscal Year Ending March 2026 announced on May 15, 2025 as follows.

Please note that there are no changes to the full-year forecast (consolidated/non-consolidated) and the dividend forecast from the previous announcement.

## 2. Reason for revision

Since other revenue was more than expected, the forecast for revenue is higher than previously anticipated. In terms of profit, it is anticipated to exceed the previous forecast due to increased revenue and the deferral of some expenses such as program cost to 3Q onwards.
