STEP 3: Enter your member information and cooperate with the questionnaire to complete provisional registration.

STEP 4: An email for password setup will be sent to your email address. Click the URL in the email and set your password to complete the final registration.

【Exchanging for Travelist Points】

1.Register and log in to the exclusive shareholder website "ZIGExN Premium Yutai Club" using the email address and password you set up.

2.From the "Exchange for Travelist Points" page on the site, click to proceed with the exchange.

3.After acquiring the exchange code, copy the displayed code and exchange it for Travelist Points on your "My Page" within the Travelist app.

4.The exchange for Travelist Points is complete.

【Notes】

- An email address is required to register for the ZIGExN Premium Yutai Club. Please configure your email settings in advance to allow emails from the domain "@premium-yutaiclub.jp".

- **Your shareholder number** and **postal code** are required to log in to the ZIGExN Premium Yutai Club.

- **How to check your shareholder number:**

- **For shareholders as of the March 31 record date:** Please check the shareholder number printed on the "Notice of Resolution of the General Meeting of Shareholders" or the "Statement of Dividend" sent in June each year.
- **For shareholders as of the September 30 record date:** No documents will be sent by mail. If you do not know your shareholder number, please contact the shareholder registry administrator below.

3. Regarding Point Carry-over

Starting now, the number of times shareholder benefit points can be carried over has changed **from once to twice**. Points can be carried over only if a shareholder is recorded in the shareholder registry with the same shareholder number for one or more consecutive record dates (as of March 31 and September 30) and continuously holds 100 shares or more. This allows for **a maximum of three periods' worth of points to be exchanged at once**.

However, please be aware that points will be forfeited and cannot be carried over if the shareholder number changes due to selling shares, a change in name to someone other than the shareholder, inheritance, or if the number of shares held falls below 100 by the record date.

4. Use and Prohibited Acts Regarding Shareholder Benefits

1. The use of our shareholder benefits (including benefit points and exchange codes for Travelist Points that can be issued with them; the same shall apply hereinafter) is limited to the shareholder. However, family members living in the same household as the shareholder may also use them.
2. For any reason whatsoever, it is prohibited to transfer, lend, sell, resell, or cash in shareholder benefits to a third party, regardless of whether it is for a fee or free of charge.
3. The Company shall be able to invalidate any shareholder benefits that it determines have been illicitly acquired or used in violation of the provisions of this article, suspend the provision of benefit services, and demand the return of the shareholder benefits.
