Tokyo, Japan, November 6, 2025—At a meeting on November 6, 2025, the ZACROS Corporation Board of Directors resolved as follows:

Details

1. Organizational Change

To strengthen our business operational base, and advance our “2030 Business Plan”, we will implement the following organizational changes:

- We will establish a new “Life Solutions Business Unit”. The existing “Wellness Business Unit” and “Environmental Solutions Business Unit” will be integrated into this new organization.
- The Life Solutions Business Unit will comprise “Packaging Division”, “Pharmaceutical and Medical Packaging Division”, “Container Division”, and “BioPhaS Division (separated and newly established from “Medical Solution Division”).
- “Medical Business Division” (excluding the portion separated as “BioPhaS Division” will be placed under the supervision of “Head of Technical Development” to strengthen collaboration with “R&D Center”.
- We will establish “Quality Management Department” to improve quality and reliability.
