### Notice Regarding Establishment and Investment in Investment Limited Partnership

DeNA Co., Ltd. would like to announce that at the Board of Directors meeting today, we approved the establishment and investment in the Delight Ventures Builder III Investment Limited Partnership (ILP) as outlined as following.
