### **Notice Regarding Changes in Specified Subsidiary**

At the board of directors meeting held today, the Company resolved to make an additional investment in its consolidated subsidiary, TC Pacific Construction, LLC. As a result, the company will become a specified subsidiary. Details are as follows.

#### **1. Reason for the change**

TC Pacific Construction, LLC is engaged in the construction business in Guam, a U.S. territory. To stabilize the financial and operational foundation of the company and to complete the construction projects currently underway, we have decided to make an additional investment. As a result of this additional investment, the amount of investment in the company will be equivalent to 10% or more of our capital, and therefore, the company will be classified as a specified subsidiary.
