Advance Create Co., Ltd. announces the results of the exercise of voting rights at the 30th Annual General Meeting of Shareholders held on December 18, 2025, as described below. All proposals were approved and adopted as originally proposed.

1. Details of matters to be resolved

Proposal No.1 Election of Eight Directors

To elect eight directors of Yoshiharu Hamada, Koichi Murakami, Takanori Tasaka, Yoji Sakurai, Asako Shimazu, Narihiro Osakada, Hidenori Shinohara and Atsushi Narukawa.

Proposal No.2 Election of Three Corporate Auditors

To elect three corporate auditors of Hiroyuki Asada, Atsushi Yagai and Yasuaki Fukuda.

The total number of voting rights confirmed for each resolution, including those exercised beforehand prior to the day before the 30th Annual General Meeting of Shareholders and those exercised by some shareholders present at the meeting, met the requirements for approval, and the resolutions were lawfully passed in accordance with the Companies Act. Therefore, the number of voting rights of some shareholders present at the meeting whose approval, disapproval, or abstention could not be confirmed has not been included in the calculation.
