Notice Regarding Progress on Share Repurchase

On November 12, 2025, the Board of Directors of Carlit Co., Ltd. (hereafter “the Company”) resolved to repurchase treasury shares, pursuant to provisions of Article 156 of the Companies Act, applied by replacing terms pursuant to provisions of Article 165, paragraph (3) of said Act.
