The Company announces that, today, it completed the acquisition and has changed the name of the company to MABUCHI MOTOR NPM CO., LTD

(Note2) Nippon Pulse Motor has subsidiaries, as no consolidated financial statement has been prepared, individual financial statements are stated above, with the figures in parentheses indicating simple aggregate number of Nippon Pulse Motor and its ten subsidiaries. Note that while Nippon Pulse Motor's fiscal year ends in April, some of its subsidiaries have fiscal years ending in December, January and February, and financial statement at the end of each of their fiscal years are simply combined. In addition, as Nippon Pulse Motor and its subsidiaries have intercompany transactions, some internal offsets are expected.
