## **Notice of Relocation of Head Office and Partial Amendments to the Articles of Incorporation**

FP Partner Inc. (the "Company") would like to announce that at a meeting of the Board of Directors held on January 14, 2026, it passed a resolution to submit a proposal for partial amendments to the Company's Articles of Incorporation to the Ordinary General Meeting of Shareholders scheduled to be held on February 27, 2026 in connection with the relocation of our head office as follows.

### 1. Head office relocation

#### (1) Location of head office after relocation

FP Asakusabashi Building, 1-1-8 Asakusabashi, Taito-ku, Tokyo

#### (2) Reasons for relocation

The Company will relocate its head office to a building owned by the Company in order to ensure the stability of long-term business operations, to make effective use of management resources by reducing rental costs, and to respond flexibly to future expansion and diversification of its business activities.

#### (3) Date of relocation

March 2026 (planned)

#### (4) Impact on business performance

The estimated amount of relocation expenses, etc. to be incurred in connection with the relocation of the head office has been incorporated into the full-year earnings forecast for the fiscal year ending November 30, 2026, which is disclosed in the Financial Results for the Fiscal Year Ended November 30, 2025, announced today. If any new important matters that may affect our business results arise in the future, we will promptly announce them.

2. Partial amendments to the Articles of Incorporation

(1) Purpose of amendments to the Articles of Incorporation

For the reasons stated in the preceding paragraph, Article 3 (Location of Head Office) of the current Articles of Incorporation is to be amended.
