The Company hereby announces that, at a meeting of its Board of Directors held on January 20, 2026, it resolved to distribute dividends of surplus, with a record date of December 31, 2025, as follows.

#### 2. Reason

The Company recognizes that the return of profits to shareholders is an important management issue. The Company's basic policy is to enhance internal reserves in preparation for future business development in order to enhance and strengthen its corporate structure, as well as to pay stable dividends taking business performance into consideration.

Based on the above policy, the Company has decided to pay a commemorative dividend of 2 yen per share to express its gratitude to shareholders who have supported and continue to support the Company since the new Representative Director and President was appointed and new management structure was launched on April 1, 2025.

As a result, the year-end dividend for the fiscal year ended December 2025, which was determined to be 13 yen per share, will be 15 yen per share including the commemorative dividend for launch of the new management structure. Resultant annual dividend will be 28 yen per share.
