### ***Notice of changes in Members of the Board, Representative Executive Officers, and Executive Officers***

NEC Corporation (NEC) today announced that it has decided on appointments for the Board of Directors effective as of the date of the Ordinary General Meeting of Shareholders (GMS) scheduled to be held in June 2026. Furthermore, at the meeting of its board of directors held today, NEC decided on appointments for Representative Executive Officers and Executive Officers effective as of April 1, 2026.

These changes will enable NEC to vigorously advance the implementation of its new mid-term management plan, which will start in fiscal 2026, and to establish a framework for further enhancing corporate value through the integration of diverse perspectives and expertise.

Specifically, to accelerate global business expansion and strengthen insight and diversity regarding global changes in the technology industry, NEC will appoint two new foreign nationals as independent outside directors.

Furthermore, to more clearly position divisions as a core pillar of management while maximizing overall strength and synergies across the entire NEC Group, a structure will be established where executive leaders are appointed in four domains: IT Services, Social Infrastructure, Technology & Innovation, and Corporate. Consequently, business units will be discontinued.
