

Notification of repurchase of shares of common stock

Tokyo, January 29, 2026 Hitachi, Ltd. (TSE:6501, "Hitachi") today announced that the Board of Directors resolved to authorize the repurchase of its own common stock pursuant to Article 459, Paragraph 1 of the Companies Act of Japan and Article 32 of Hitachi's Articles of Incorporation, as follows.

1. Reason for repurchase

Hitachi views the return of profits to shareholders through enhancing corporate value from a mid- and long-term perspective, paying stable dividends and repurchasing its own shares flexibly as an important managerial issue. In light of its current financial standing and the progress of asset sales, Hitachi has decided to execute a share repurchase to further expand shareholder returns.

2. Outline of the repurchase

(1) Class of shares to be repurchased	Common stock of Hitachi
(2) Aggregate number of shares to be repurchased	Up to 30 million shares (0.67% of the number of outstanding shares (excluding treasury stock))
(3) Aggregate amount of repurchase	Up to 100 billion yen
(4) Period of repurchase	From January 30, 2026 to April 30, 2026
(5) Method of repurchase	Expected open market purchase through the Tokyo Stock Exchange

A part or all of the repurchases may not be carried out depending on market conditions and other factors.
