(headquarters: Saitama-city, Saitama, President: Teruo Takahashi, “NPR”).

## 3. Purpose of the Change

As announced in the "Notice Concerning Reorganization (Company Split) of Our Group" dated November 26, 2025, the Company recognizes that the best way to maximize corporate value through integration is to abolish the vertical business lines of Riken and NPR, and to further enhance the creation of synergies by reorganizing the organizations of both companies by business segment. With this understanding, the Company has decided to transition to a "business holding company" through a divisional structure of strategic business units, and to reorganize subsidiaries on April 1, 2026. Accordingly, the Company will change the trade name and relocate the head office of both companies.
