

V. Change in the Structure

1. Establishment, abolition and consolidation of organizational units
 - Abolishment of “Marketing Management Division”

In order to increase the speed of decision-making and execution in our Processed Foods Business, we will constructively dissolve the “Marketing Management Division” and transfer its existing functions, such as sales promotion and product development, to each business unit, thereby strengthening our cohesive and integrated value chain.

Furthermore, to accelerate our medium- to long-term growth strategy, we will establish the “Processed Foods Marketing Strategy Office” as an elite strategic team reporting directly to the Head of the Processed Foods Business Division. This new office will strongly promote various initiatives for value creation, including brand strategies and new category creation that specialize in innovative concepts.

- Abolishment of “Business Strategy Division”

In order to strengthen cross-business strategies, collaboration and co-creation with external companies, and new business creation, the “Business Strategy Division” will be abolished, and its functions will be transferred to and consolidated into the “Corporate Planning Department”. The name of the “Corporate Planning Department” will then be changed to the “Corporate Strategy Department,” and the Strategy Promotion Office will be newly established under it.

- Review of Risk Management System and Consolidation of Committees

In order to incorporate our long-standing compliance activities into the company-wide risk management system and to centrally manage all company-wide risks, the “Risk Management Committee” and the “Compliance Committee” will be integrated into the “Risk Management Committee,” a voluntary advisory committee to the Board of Directors, thereby further strengthening our risk management system.

- Establishment of “Sports & Entertainment Business Division” and abolishment of “Sports Business Department”

Following the opening of HOKKAIDO BALLPARK F VILLAGE and ES CON FIELD HOKKAIDO in 2023, and with the monetization of our ballpark business advancing, the " Sports Business Department " will be abolished, and the "Sports & Entertainment Business Division " will be established. This reorganization aims to expand our corporate value by further advancing community development and creating synergies between our food and sports businesses.

- Consolidation of “DX Promotion Department” and “IT Strategy Department”

In order to strengthen the company-wide promotion of DX (Digital Transformation) and AI (Artificial Intelligence) and to reliably advance the replacement of business systems, the two abovementioned departments will be consolidated to form the “IT & DX Promotion Department.”

- Consolidation of “Sustainability Department” and “Public Relations Department”

In order to strengthen the sustainability strategy in corporate communications, the two abovementioned departments will be consolidated to form the “Public Relations & Sustainability Department.”

2. Name Change of Organizational Units

- Name change of “Overseas Management Division” and “Imported Fresh Meats Sales Division.”

The name of the “Overseas Management Division” will be changed to “Overseas Processed Foods Management Division,” and the name of the “Imported Fresh Meats Sales Division” will be changed to “Overseas Fresh Meats Business Division.”

- Name change of “Compliance Department”

Amid the organizational culture reforms based on employee engagement activities that began this fiscal year, to further strengthen the company-wide risk management system, the "Compliance Department" will be renamed the "Risk Management Department," and the "Compliance Consultation Office" will be established under it.

3. Supervision change of affiliated company

- Supervision change of Nipponham Engineering Ltd.

In line with the above consolidation of the “Sustainability Department,” the supervision of Nipponham Engineering Ltd. will be changed from the “Sustainability Department” to the “Corporate Strategy Department.”
