The planned organizational changes effective April 1 are as follows:

1. The Plants & Infrastructure Systems and the GX Solutions will be integrated into a single Plants & Infrastructure Systems.
 - Centered on the project engineering functions of the GX Solutions, the expertise and resources of both organizations will be unified to further expand the business and strengthen competitiveness.
2. The Data Center & Energy Management Department of the Growth Strategy Office will be transferred to the Logistics, Thermal & Drive Systems, which will be renamed the Industrial Solution Systems.
 - The data center business handled by the Growth Strategy Office's Data Center & Energy Management Department is expanding rapidly due to the swift proliferation of generative AI. Seizing this opportunity, by collaborating with the cooling systems and power generation systems businesses, we aim to maximize synergy effects and achieve independence as a business division.
