**Notice Regarding Partial Correction to the “Notice Regarding Issuance of New Shares and 25th Series Stock Acquisition Rights through Third-Party Allotment”**

At its Board of Directors meeting held on January 29, 2026, Metaplanet Inc. (the "Company") resolved to issue its common stock (hereinafter referred to as the 'Shares') and the 25th Series Stock Acquisition Rights (hereinafter referred to as the 'Stock Acquisition Rights') through a third-party allotment (hereinafter referred to as the 'Third-Party Allotment'). The issuance of the Shares and the issuance and exercise of the Stock Acquisition Rights for the purpose of raising funds shall be referred to as 'Fundraising'.
