Notice Concerning Election of Board Directors and Change of Executive Officers

HAZAMA ANDO CORPORATION (the "Company") hereby announces that, at a meeting of its Board of Directors held today, the Company resolved the election of Board Directors and changes to Executive Officers described below.

The election of Board Directors is scheduled to be formally determined at the Annual General Meeting of Shareholders for the FYE March 31, 2026 to be held in June 2026 and at the Board of Directors meeting following the Annual General Meeting of Shareholders.
