Notice Concerning Change of Independent Auditor

ZOOM Corporation (the “Company”) hereby announces that it has resolved, at a meeting of the Audit and Supervisory Committee held today, to change its independent auditor, who performs the audit certification set forth in the Article 193-2, paragraphs (1) and (2) of the Financial Instruments and Exchange Act, and at the Board of Directors meeting held on the same day, it was resolved to submit the proposal titled “Appointment of Independent Auditor” to the 43rd Ordinary General Meeting of Shareholders scheduled for March 26, 2026. The details are as described below.

3. Reason for selecting the party stated in 2. (1) as a candidate for independent auditor

The Audit and Supervisory Committee selected Forvis Mazars Japan Audit LLC as the candidate for the independent auditor because this audit firm possesses strengths in its global network, particularly in Europe and the Americas where our Group has important bases. With an affiliated firm within this network assuming the role of independent auditor for our German subsidiary starting in fiscal year 2025, we determined that appointing the same audit firm for the Company would enable the establishment of an efficient and highly effective audit framework across the entire group. Furthermore, after comprehensively considering the firm's expertise, independence, quality control systems, and audit fees, the Committee concluded it is well-suited to serve as our independent auditor.

6. Reason and background for determining or leading to change

Our current independent auditor, Grant Thornton Taiyo LLC, will complete its term upon the conclusion of the 43rd Ordinary General Meeting of Shareholders scheduled for March 26, 2026. While we believe the current auditor possesses a sufficient framework to ensure the appropriate and proper execution of audits, for the reasons stated in Section 3 above, we hereby appoint Forvis Mazars Japan Audit LLC as the new auditor to succeed them.
