Notice Concerning Dividends from Surplus (Increase)

Zeria Pharmaceutical Co., Ltd. (the "Company") hereby announces that it has resolved, at a meeting of the Board of Directors held on May 8, 2026, to issue dividends from surplus with March 31, 2026 as the record date and to file a motion to that effect at the 72th Ordinary Stockholders' General Assembly scheduled to be held on June 26, 2026, as follows.

2. Reason for the dividend Amount

The Company regards the return of profits to shareholders as one of its highest management priorities, and its basic profit distribution policy is to pay stable and continuous dividends.

Taking into account the Company's performance for the current fiscal year and other factors, the Company has decided to pay a year-end dividend of 25 yen per share, an increase of 1 yen from the previous fiscal year. As a result, the annual dividend will be 49 yen per share, including the interim dividend of 24 yen per share (an increase of 2 yen from the annual dividend of the previous fiscal year).
