Notice Concerning Change of Accounting Auditor

Fujikura Ltd. (the “Company”) hereby announces that its Audit and Supervisory Committee resolved, at a meeting held on May 20, 2026, to change its accounting auditor, who performs the audit certification set forth in Article 193-2, Paragraphs 1 and 2 of the Financial Instruments and Exchange Act. In addition, at the Board of Directors meeting held on the same day, it was resolved to submit a proposal for the election of an accounting auditor to the 178th Annual General Meeting of Shareholders scheduled to be held on June 26, 2026. The details are described below.

3. Reason for selecting the party stated in 2. (1) as a candidate for accounting auditor

The Audit and Supervisory Committee selected Deloitte Touche Tohmatsu LLC as a candidate for accounting auditor because PwC Japan LLC has been conducting audits as accounting auditor for a long period of time, and the appointment of another accounting auditor can be expected to provide audits from a new perspective. In addition, Deloitte Touche Tohmatsu LLC has a global auditing system, expertise, independence, quality control system, and other systems that enable audits to be conducted appropriately. The Committee therefore determined that Deloitte Touche Tohmatsu LLC is an appropriate candidate for accounting auditor in our company.

The term of service of PricewaterhouseCoopers Japan LLC as the Company's accounting auditor will expire upon the conclusion of the 178th Annual General Meeting of Shareholders scheduled to be held on June 26, 2026, and thus it was decided to propose the election of Deloitte Touche Tohmatsu LLC as the new accounting auditor.
