### 1. Background of the Change

On June 2, 2026, a Large Shareholding Report (Amendment Report) was submitted to the Kanto Local Finance Bureau by the shareholder listed below, indicating an increase in the shareholding ratio. As a result, the Company has confirmed a change in its major shareholder.

The Company has not independently verified the actual number of shares beneficially owned under the name of the said shareholder.
