The Monogatari Corporation announces that we have made the partial correction to the title and contents of the “Notice Regarding Capital Increase in a Subsidiary (Designation as a Specified Subsidiary) ” released on May 18, 2026. The corrected portions are underlined below.

1. Reason for the Correction

With respect to the capital increase carried out by the Company in Storytellers USA, Inc., a holding company of Shin Nihon Kosan, Inc., which operates restaurants in the United States, it has been determined that the amount of paid-in capital of Storytellers USA, Inc. after the capital increase does not reach 10% or more of the Company’s paid-in capital. Therefore, Storytellers USA, Inc. does not qualify as a specified subsidiary.
