Therefore, the Company recognizes that there are no business restrictions, risks, or advantages arising from belonging to the corporate group of the parent company, etc., and that the independence of the Company’s management is ensured.

The sole Director of the Company is Masaru Wasami, who also serves as the Company’s Representative Director.

3. Matters concerning transactions with the controlling shareholder, etc.

4. Implementation of measures to protect minority shareholders when conducting transactions with the controlling shareholder

Masaru Wasami, the founder and Representative Director of the Company, is the controlling shareholder, holding a majority of the Company's voting rights. Transactions with the controlling shareholder are conducted in accordance with laws and regulations as well as internal rules and are subject to resolution by the Board of Directors when necessary. In addition, the Audit & Supervisory Board and Internal Audit Office conduct audits to monitor the appropriateness of such transactions.

If the Company conducts any of such transactions, it will adopt the basic policy of applying appropriate terms in line with the terms of general transactions. The appropriateness of the transaction details and terms will be reviewed by a Special Committee composed of Independent Outside Directors and will be decided by the Board of Directors or other decision-making bodies based on the results of the review to ensure that the interests of minority shareholders are not harmed.
