Notice of Monthly Information for May 2026

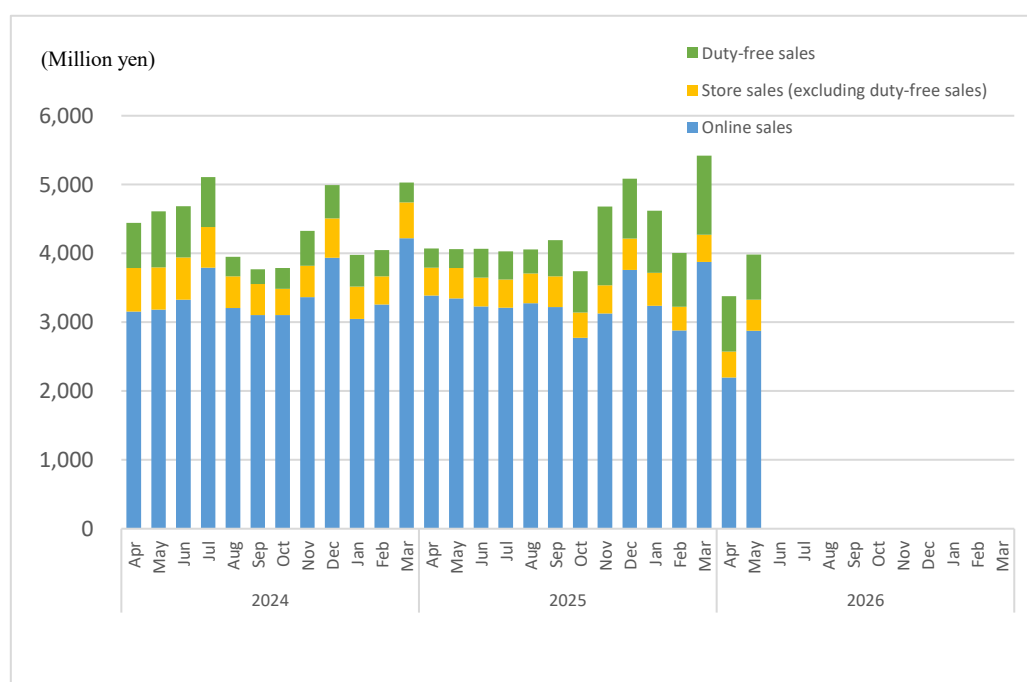
This is to announce the monthly information for May 2026 as follows.

In May, duty-free sales remained strong in both the Camera and Watch Businesses. However, although EC sales improved from April, they remained below the previous year's level, due in part to the suspension of sales on certain domestic online marketplaces (Rakuten Ichiba and Yahoo! Shopping) following the replacement of the Company's core system on April 1, 2026. As a result, overall net sales were slightly below the previous year's level.

The number of new web members continued to grow steadily.
