THE TOWA BANK, LTD. (the “Bank”) hereby announces that it has completed a calculation of the total amount of unrealized losses on securities (held-to-maturity debt securities) held by the Bank as of the end of the first quarter of the fiscal year ending March 31, 2027, as follows.
