3. Other Matters Necessary for Investors to Fully Understand and Make Sound Judgments regarding the Company's Information

- (1) WASAMI CO., LTD.'s main purpose is the personal asset management of Masaru Wasami, the Representative Director of the Company, and in addition, it is engaged in real estate leasing and management business, etc.

- (2) The relationship between WASAMI CO., LTD. and the Company is as follows.

(i) Capital relationship

As of June 30, 2026, WASAMI CO., LTD. holds 20,200,000 shares (Voting rights ownership ratio: 14.94%) of the Company's stock. Although its shareholding ratio is less than 20%, it is classified as an other related company because it has substantial influence.

(ii) Personnel relationship

Masaru Wasami, the Representative Director of WASAMI CO., LTD., is the Representative Director of the Company. This individual is the only officer to hold a concurrent position at both WASAMI CO., LTD. and the Company.

(iii) Transactional relationship

There are no notable transactional relationships between the Company and this shareholder.
